Know all Men by These Presents, That the City of Caney,

In the County of Montgomery and State of Kansas, a duly organized City of the third class, under the laws of the State of Kansas, is indebted to the bearer hereof in the full sum of Five Hundred and Twenty-Five (\$525.00) Dollars, which said sum the City of Caney undertakes and promises to pay to the bearer hereof, twenty years from this date, at the rate of Kansas, in the City of New York, in the State of New York, with interest at the rate of five per cent. per annum from date, payable annually on the first day of June according to the twenty interest coupons hereto attached, numbered from one to twenty inclusive.

This Bond is issued by the Mayor and Council of said City of Caney at a regular meeting thereof, for the construction of Public Improvements in said City of Caney, pursuant to the authority given under Article three, Chapter nineteen of the compiled Laws of Kansas, by Dassel, 1885, and pursuant to and conformable to the instructions of a majority of the votes of the said City of Caney, given at an election duly and properly called, had and held in said City to take the sense of said City on said subject. And it is hereby certified that each and every and all the requirements and conditions of the law have been fulfilled and complied with, prior to the issuance of this Bond, which is the only one issued under said authority. And that said Mayor and City Council have been duly and legally authorized to issue the same and that they have obeyed all the requirements of the law in issuing the same.
