Charter

OF

The Caney Lodge No. 324, A. F. and A. M. Building Association.

The undersigned, citizens of the State of Kansas, do hereby voluntarily associate ourselves together for the purpose of forming a private corporation under the laws of the State of Kansas, and do hereby certify:

FIRST.

That the name of this corporation shall be THE Caney Lodge No. 324, A. F. and A. M. Building Association.

SECOND.

That the purpose^s for which this corporation is formed are to purchase, own, sell and convey real estate, chattels, real and personal. Also to erect and maintain on its real estate a building or buildings with right to use, lease and occupy the same.

THIRD.

That the place where its business is to be transacted is at Caney, Montgomery County, Kansas.

FOURTH.

That the term for which this corporation is to exist is Ninety-nine (99) years.

FIFTH.

That the number of directors trustees of this corporation shall be Seven (7).
and the names and residences of those who are appointed for the first year are:

Dan'l H. Plowman, Edward Cochrane, William H. Christian, Philander F.
F. Wellman, Joseph E. Stone, and Ulysses S. Key all of Caney, Montgomery
county Kansas and Jonas C. Gilmore of Havana, Montgomery County, Kansas.

SIXTH.

That the estimated value of the goods, chattels, lands, rights and credits owned by
the corporation is Five Thousand (\$5,000.00) Dollars.

That the amount of the capital stock of this corporation shall be _____
