The PSU-KNEA Negotiating Team has reached a tentative agreement with the PSU Administration. We are putting the tentative agreement to a vote for ratification. You can access the ballot in GUS. The voting is open now and will conclude at noon on the 30th of August.

## Why join PSU-KNEA?

PSU-KNEA members negotiate the raises that faculty receive each year, negotiate the faculty contract, and work to see that the rights of faculty are protected. PSU-KNEA is open to all faculty who are welcome to join to ensure their voice is heard and their interests are served. Dues are approximately \$32 per pay period for faculty on a 9-month contract. ## From the Desk of the President, August 6, 2019

The PSU-KNEA Negotiating Team and the administrative negotiating team have tentatively agreed to a 2.5% raise on our base. The agreement is pending ratification by PSU-KNEA and by the Board of Regents. The ratification vote for PSU-KNEA will occur soon. Stay tuned.

After Governor Kelly proposed a 2.5% raise for all state of Kansas employees and the Kansas House of Representatives voted in favor of the raise back in March, the PSU-KNEA Negotiating Team decided that whether or not the Senate approved 2.5%, we would forward that number to the PSU administrative negotiating team. The Kansas Senate then took away all of that in their budget proposal in March, but then the final approved budget in May allocated funds to Higher Education. Although the raise is not 3% target that I suggested at the beginning of our last academic year, the 2.5% is a move in the right direction to compensate for cost of living increases. I want to thank the Negotiating Team for all their work. The members this year were: Khamis Siam, Tim Thomas, Tim Bailey, Linden Dalecki, and Mark Johnson.

On different note, on July 18th I wrote to Kevin Bracker, our acting Faculty Senate President, to ask about how long the Senate wanted the PSU-KNEA President to speak in the Opening Meeting since historically the meeting had been run by Faculty Senate. He wrote back and told me that because of changes, that PSU-KNEA had not been included on the agenda. We met on Monday, July 29th, and that is when I found out that the Opening Meeting was no longer a Faculty Senate Meeting. I worried about censorship of faculty. The next day the entire campus received a message from Abby Fern that the meeting was no longer a Faculty Senate Meeting.

Since PSU-KNEA has addressed the audience in the Opening Meeting as long as anyone could remember, I set up an appointment with President Scott to inquire about it. On the day of our meeting (Monday, August 5th), right before we met, I noticed a message from Kevin that included an invitation to me so that the PSU-KNEA President could address the faculty at a General Faculty Senate Meeting, a meeting that would follow the Opening Meeting. When I met with President Scott, I mentioned that I was concerned that if the PSU-KNEA President did not stand before the audience at the Opening Meeting, it would be the first time since PSU-KNEA's inception and it might suggest to some that the administration was censoring faculty. When I returned from our meeting, I wrote to Kevin to accept his invitation to talk to the Faculty at the General Faculty Meeting.
