Why is Open Access Important?

- Provides Access to Needed Information Worldwide
- Increased Opportunities to Publish Research
- Increased Usage & Citations
- Fulfills Funding and Other Agency Requirements
 - NIH, cOAlition S Plan S, and OSTP
- OA Very Important at PSU
- Dark Side of Open Access Journals

OSTP Mandate

- OSTP Memo (dated August 25, 2022) Applies to Research Supported by Federal Funding and Mandates it Be Freely Available Without Embargo
- Criticisms
 - Unsustainable APCs, for Some
 - Lack of Sufficient Funding from Some Funding Agencies, Institutions
 - Recommendations for Universities to Stop
 Subscriptions and Pay for Open Access Publishing
- Options?

Transformative Agreements

- First Transformative Agreement Found in ESAC Transformative Agreement Registry 2014
- Disadvantages
- Sometimes, Not Sustainable
 - Costs
 - Limitations

cOAlition Plan S

- cOAlition S International Consortium of Research Funding & Performing Organizations Committed to OA
- Plan S, Launched in 2019, Effective in 2021
 - 10 principles
- Mandates That Research Supported by Public & Private Grants Be Freely Available Without Embargo
- Criticism & the Response (2019)
 - Plan S Letter

Open Access Memberships

- Several publishers offer open access memberships
 - For some Publishers, There are Discounts on APCs for Researcher Authors
 - More Predictable Pricing Than Transformative Agreements with No APC Limits
 - OA Memberships are Possible Viable Alternatives to Transformative Agreements
