1. Volume II of the Bird Banding Manual will include sections on general instructions on techniques, sexing and aging birds, capture, auxiliary marking and record keeping. Additional topics can be added. Please send us your suggestions or contributions to the Manual. We received many useful suggestions during the preparation of Volume I.

The Volume II chapter on bird capture has been assembled in the Bird Banding Laboratory and is now being edited by Parker Reed, a bander living at 27 Hayes Avenue, Lexington, Massachusetts 02173. If you have suggestions that should be included in the chapter, please write to Mr. Reed.

Merrill Wood, Department of Biology, Pennsylvania State University, University Park, Pennsylvania 16802, has furnished us sex and age identification material for many species. This material is being reviewed and edited by a group of volunteers coordinated by Mrs. Bradley Fisk, 17101 SW. 284th Street, Homestead, Florida 33030. Much work remains to be done so Mrs. Fisk could use additional assistance. We are thankful to all who are helping or have offered.

2. Please review the attached list of permittee numbers for banders whose banding station location listing has not been corrected and returned to the Bird Banding Laboratory. If your permit number appears on the list and you have returned your copy, it may have been lost in the mail. If so, we can send you another copy to update. Please take whatever action is necessary so that we may remove your name from the list.
3. The problem of reporting station band returns and their processing is to be examined closely in the near future. The reporting of returns probably will require special forms and different information than is currently requested from banders reporting recoveries and foreign retraps.


We request that all banders continue to record returns for possible future processing. At the moment we are interested only in receiving the most unusual returns for immediate inclusion in our files. Such

returns document extreme longevity or unusual seasonal occurrence (e.g., a "summer only resident" wintering in the same 10' block instead of Central America). Please indicate the basic banding data for any of your unusual returns in the remarks section of the Bird Band Recovery Report (Form 3-1807).

4. On the Migratory Bird Salvage Report we received a number of questions regarding the reporting of tower kills and salvage of large numbers of birds. They need not be reported individually but can be grouped by species and disposal categories. We will report data on salvaged birds to the Division of Law Enforcement for inclusion in its annual report on Migratory Birds and Eagles Taken by Scientific and Special Purpose Permittees.

Except for MTAB-9, which relates to age and sex criteria, MTAB's previous to 18 are obsolete and banders need not retain them. Most pertinent material in the early MTAB's has been included in the Manual.

Banders authorized to use auxiliary markers on birds are cautioned to use judgment in their use. Serious public relations problems arise from birds being injured or killed by marking devices. Please let us know of any marker that you use that you think has limitations or faults. Long leg streamers, wing markers, nasal saddles, and neck collars have been the culprits this year.
