The following is copy of the settlement made at 19 Sheridan, by the undersigned Board Members.

I took up the case of Louis Gillet, wherein he has a roll. Tom Cunningham settled this case for two (2) ft. of 6 ft. work, and 4 ft. of horseback.

I also took up the case of Guy Marshall and settled with Tom Cunningham for Six (\$6.00) Dollars.

Case of Check #5, Mike Smith. This dispute is over question of yardage that was driven in the side of horse-back that was cut in second cross-cut. The company contends 12 ft. should apply. We contend 6 ft. should apply. Case to be written up.

The case that was settled by Board Member Craig is parallel with Check #5. Decision on Check #5 is to govern the case that Craig settled.

Check #141, Loomis, where miners contends for room turning. Mine management gave orders to turn place 24 ft. wide. Instructions of mine management was carried out and place was turned 24 ft. wide. Board holds that Check #141 has no case.

Check #184, Luke Holliday, dispute over a place where Brother Holliday narrowed his place down to 6 ft. work without instructions or directions from mine management. Mine Committee stated that Brother Holliday made the statement that mine management had not told him to narrow down to 6 ft. work. In this case, the company is sustained in their contention.

Case of J.P. Pike, wherein a dispute arose over cross-cut. Brother Pike was not present. The Mine Management claim that it was not a cross-cut, but instructions
