## ARTICLE XV. Section 8.

Sec. 8. When a person who has not been a member of the organization three months or more secures a Transfer Card from a local union in a District where a dispensation has been granted, said Transfer Card shall not be accepted by any local in a different District, unless the holder agrees to pay the difference between the initiation fee already paid and the initiation fee of the District where he desires to deposit his card.
