Scope and Content	Court proceedings in Washington, D.C. on March 9 and 10 of 1936 on the application for a construction permit, frequency request, and power request for a radio station in Pittsburg, Kansas by the Pittsburg Broadcasting Co. The proceedings discuss the logistics of building a station and tower, the range and possible interference from other stations, positions and duties of the people involved, and the broadcasting situation.

Biographical Note	E. V. Baxter and Lester L. Cox began radio station KOAM on October 11, 1937. From 1964-2004, Dan Willis hosted the morning show. KOAM-TV had its first broadcast on December 13, 1953. On May 11, 1981, the KOAM radio station was sold to American Media Investments and changed to KKOW. The television station was not changed. The two stations remained split until the early 2000s when Gene Bicknell, local businessman, bought American Media Investments.
